Thank you for your confidence in the Ellipsis European Convertible Fund.

What changes will your OPC undergo?

Following the acquisition by Ellipsis Asset Management of the convertible bond asset class management business of Edmond de Rothschild Asset Management, the two management companies have decided by mutual agreement to merge the EdR Europe Convertibles sub-fund of the EdR Fund SICAV into the Ellipsis European Convertible Fund FCP.

The merger of these two funds, which implement similar management strategies, will make Ellipsis Asset Management's fund offering more transparent and will increase the total assets of your fund, which should enable the fund to benefit from economies of scale. Please note that, in any event, this merger will not affect the management of your fund, its risk profile or the fees and charges levied on it.

Finally, please note that this operation does not require any action on your part, as it is your fund that absorbs the sub-fund of the EdR Fund SICAV.

This merger-absorption operation is subject to the prior approval of the Commission de surveillance du secteur financier luxembourgeois and the information of the Autorité des marchés financiers. It will come into effect on 10 December 2024.
